AN ACT to amend Tennessee Code Annotated, Title 11, Chapter 14, Part 1, relative to state natural areas.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 11-14-108(b)(2), is amended by adding the following appropriately designated subdivision, keeping all of the subdivisions in alphabetical order:

( ) John and Hester Lane Cedar Glades. An area of approximately 45 acres located in Wilson County and within the Central Basin Physiographic Province. This site consists of a complex of pristine limestone cedar glades and mixed cedar-hardwood forests, and protects one of the largest known populations of the rare and endemic federal and state listed Tennessee coneflower, as well as a population of the state and federal listed leafy prairie-clover. This ecologically significant site also protects numerous other species of rare cedar glade flora.

SECTION 2. Tennessee Code Annotated, Section 11-14-108(b)(1)(C), is amended by deleting the language, "Bon Aqua Woods" and substituting instead the language "John Noel State Natural Area at Bon Aqua".

SECTION 3. Tennessee Code Annotated, Section 11-14-108(b)(2)(H), is amended by deleting the language "one hundred twenty-two (122)" and substituting instead the language "one hundred twenty-eight (128)".

SECTION 4. Tennessee Code Annotated, Section 11-14-108(b)(2)(EE), is amended by deleting the language, "three hundred seventy-five (375)" and substituting instead the language "nine hundred thirty-one (931)".

SECTION 5. Tennessee Code Annotated, Section 11-14-108(b)(2)(QQ), is amended by deleting the language, "seven hundred eighty-three (783)" and substituting instead the language "seven hundred seventy-six (776)".

SECTION 6. Tennessee Code Annotated, Section 11-14-108(b)(2)(UU), is amended by deleting the language, "one hundred seventy-three (173)" and substituting instead the language "one hundred sixty-two (162)".

SECTION 7. Tennessee Code Annotated, Section 11-14-108(b)(2)(EEE), is amended by deleting the language, "four hundred twenty (420)" and substituting instead the language "four hundred twenty-eight (428)".

SECTION 8. This act shall take effect upon becoming a law, the public welfare requiring it.
