AN ACT to amend Tennessee Code Annotated, Title 4; Title 5; Title 6; Title 8; Title 9; Title 10; Title 11; Title 12; Title 13; Title 16; Title 17; Title 18; Title 29; Title 33; Title 37; Title 38; Title 39; Title 40; Title 41; Title 43; Title 45; Title 47; Title 48; Title 49; Title 50; Title 53; Title 54; Title 55; Title 56; Title 57; Title 58; Title 59; Title 60; Title 62; Title 63; Title 64; Title 65; Title 66; Title 67; Title 68; Title 69; Title 70 and Title 71, relative to statutory revisions required for implementation of the annual appropriations act.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 4-3-1016, is amended in subsection (d) by deleting the language "and June 30, 2010," and by substituting instead the language "June 30, 2010, and June 30, 2011,"; and in subsection (e) by deleting the language "and June 30, 2010," and by substituting instead the language "June 30, 2010, and June 30, 2011,"; and in subsection (f) by deleting the language "year ending June 30, 2009," and substituting instead the language "years ending June 30, 2009, and June 30, 2011,".

SECTION 2. Tennessee Code Annotated, Section 4-3-726, is amended by deleting the section in its entirety.

SECTION 3. Tennessee Code Annotated, Section 4-3-727, is amended by deleting subsection (f) in its entirety and by substituting instead the following:

(f) The committee has the duty to exercise the powers over regional planning commissions provided for in §§ 13-3-101 and 13-3-102.

SECTION 4. Tennessee Code Annotated, Section 68-211-822, is amended by deleting the language "department of economic and community development's division of local planning" and by substituting instead the language "department of economic and community development".

SECTION 5. Tennessee Code Annotated, Section 57-5-205(1), is amended by deleting the language "Tennessee state planning commission" and "state planning commission" wherever such language appears and by substituting instead the language "department of economic and community development".

SECTION 6. Tennessee Code Annotated, Section 6-58-104(a)(2), is amended by deleting the language "the local planning office of the department of economic and community development,".

SECTION 7. Section 1 of this act shall take effect upon becoming a law, the public welfare requiring it. Section 2 of this act shall take effect on July 1, 2012, the public welfare requiring it. All other provisions of this act shall take effect on July 1, 2011, the public welfare requiring it.
