WHEREAS, the members of this General Assembly were greatly saddened to learn of the passing of Mr. Ricky Wayne Woodard, who served as Mayor for the Town of Westmoreland; and

WHEREAS, Mr. Woodard was an exemplary public servant and consummate professional who provided guidance, commiseration, and comfort to grieving families of the Westmoreland community as the owner, director, and manager of Woodard Funeral Home, Inc.; and

WHEREAS, Ricky Wayne Woodard served with wisdom and alacrity in his many manifold positions with City Government for twenty-two years, as Mayor of the Town of Westmoreland for ten years, and throughout his dedicated service to bereaved loved ones for more than 30 years in which positions he earned the respect of his community and clients alike for the exemplary quality of his work; and

WHEREAS, in March 2006, Ricky Wayne Woodard listened to his entrepreneurial spirit and he and his wife, Judy, purchased Woodard Funeral Home, Inc., making his dream to honor his daughter's legacy a reality; and

WHEREAS, Ricky Wayne Woodard was a dedicated civic leader who distinguished himself as a public-spirited citizen of the highest order through his work with copious boards and committees, including his charter membership with the Chamber of Commerce, and membership in the Westmoreland Rotary Club, Westmoreland Lions Club, and Westmoreland High School Advisory Board; and

WHEREAS, Mr. Ricky Wayne Woodard was born and raised in Westmoreland, and devoted the majority of his life to the community of Westmoreland; and

WHEREAS, Mr. Woodard was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

BE IT FURTHER RESOLVED, that we express our sympathy and offer our condolences to the family of Mr. Woodard.


BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
