WHEREAS, Mr. Fisher and his wife, Charlotte, serve estimably as tour guides to Washington, D.C., and, after having chaperoned school groups from the Dayton City School System for the last twenty-eight years, this dynamic couple began a tour business over ten years ago to serve students from various schools in the surrounding areas; and

WHEREAS, no stranger to accolades, Mr. Fisher came in first runner-up for Educator of the Year in 1970, was named Southeastern District Superintendent of the Year for the 1997-98 school year, and was recognized as the Dayton Chamber of Commerce Business Man of the Year in 2010; and
