WHEREAS, having viewed a television program in which a kind doctor comforted a suffering child with the gift of a cuddly teddy bear, Michael was struck with the brilliant idea to provide each patient at East Tennessee Children's Hospital with a stuffed animal on Christmas Day; and

WHEREAS, using the money he earned from doing household chores and donations from the tooth fairy, this Greenback School kindergartner poured his heart and soul into his extraordinary project; and

WHEREAS, Michael and his thoughtful idea eventually launched a community-wide movement, with eight large bags and three huge boxes of adorable teddy bears eventually being collected for distribution on Christmas Day; and

WHEREAS, a sensitive and remarkable young man, Michael Payne, Jr., is truly a shining example of how one person can make a positive difference in the world; and

WHEREAS, through this philanthropic effort, Michael has evinced his deep commitment to the honorable qualities of benevolence and love for his fellow human beings; he epitomizes the spirit that is characteristic of a true Tennessean; and

WHEREAS, we wish to seize this golden opportunity to specially recognize one of Tennessee's most outstanding young citizens; now, therefore,
