WHEREAS, the members of this General Assembly were greatly saddened to learn of the passing of the Honorable Robert "Bob" L. Moon of Signal Mountain; and

WHEREAS, Judge Moon was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, born on June 14, 1951, in Chattanooga, Bob Moon obtained his bachelor's degree from the University of Tennessee and decided to pursue a legal career, earning his Juris Doctor degree from Memphis State University's Law School; and

WHEREAS, after practicing law in Hamilton County, Judge Moon served with acumen and alacrity as a Signal Mountain City Judge for thirteen years, in which position he won the unbridled respect and admiration of his fellow members of the bench and bar, as well as the parties appearing before his court; and

WHEREAS, highly respected within his community, the Honorable Robert Moon was appointed as a Hamilton County General Sessions Judge for Tennessee in 1996; and

WHEREAS, having proven himself to be a thoughtful and dedicated jurist, he was reelected in 1998 and again in 2006 by overwhelming margins; and

WHEREAS, a firm believer in the importance of professional involvement, Judge Moon dedicated his time and energies to a number of legal organizations; he rendered sterling service as a member of the Chattanooga Bar Association and the Tennessee Bar Association; and

WHEREAS, deeply involved in his community, he also contributed his time and energies to numerous civic organizations and endeavors, including the Boys Club of Chattanooga, Rotary Club of Chattanooga, and Harrison Ruritan Club; and

WHEREAS, Bob Moon was an active and devout member of the First Presbyterian Church of Chattanooga, where he served his Lord for many years; and

WHEREAS, a true Renaissance man, Judge Moon was known throughout the region as an avid hunter and deep sea fisherman, an antique car enthusiast, and a celebrated poet; and

WHEREAS, Judge Moon was deeply devoted to his family, and always endeavored to remain true to family values of the highest order; and
