WHEREAS, Representative Sontany served as the chair of the Family Justice Subcommittee, as the secretary of the Judiciary Committee, and as a member of the Select Oversight Committee on Children and Youth; and

WHEREAS, a remarkable individual who truly appreciates the responsibilities, as well as the privileges, of leadership and citizenship, Representative Sontany has graciously donated her time and energies to many community and civic organizations, including Outlook Nashville, Nashville Thermal Transfer Corporation, Victims of Crime State Coordinating Council, Boys and

WHEREAS, a past chair of the Tennessee Economic Council on Women, Representative Sontany is also a past president of the Nashville Women's Political Caucus, and a member of Democratic Women of Davidson County and Women in Numbers (WIN); and

WHEREAS, Rep. Sontany is a member of a number of neighborhood associations, including Caldwell Abbay Hall, Castlegate, Crieve Hall, Edge-O-Lake, Flatrock Heritage, Glencliff, Glengarry Park, Hill N. Dale, Percy Priest Meadows, Piccadilly Square Homeowners, Priest Lake Park, Radnor, Raymond Heights, Saturn Drive, Wheeler Avenue, Woodbine, and Una, in addition to TMAG (Thompson Lane Murfreesboro Road Action Group); and

WHEREAS, no stranger to awards and accolades, Representative Sontany has received a number of honors, including the 1998 Public Leader of the Year Award from the Council on Mental Retardation, the 2006 Government Official of the Year from the Nashville Coalition Against Domestic Violence, the 2006 Outstanding Legislator of the Year from the Tennessee Coalition Against Domestic Violence and Sexual Violence, the Outstanding Legislative Service award from the Nashville Humane Association, the Athena Award nominee 2002 and 2006, 2008 the Outstanding Legislator of the Year from Parks and Recreation Association, the 2007 Voice on the Hill Award from Tennessee Association Alcohol Drug and Addiction Services, and the 2008 Humane Legislator Award from Humane Society of the United States; and

WHEREAS, a 2011 honoree for the AWA Women of Achievement Award, she also received the 2010 HSUS Human Legislator Award, the 2010 Rein Maker Award from Rein (Reaching Equines in Need), 2009 AFL-CIO Leadership Award, 2009 Tennessee Conservation Voters Legislative Friends Award, 2009 Animal Control Association of Tennessee (ACAT) Outstanding Animal Welfare Advocate Award; and

WHEREAS, as part of a well-deserved tribute, the Davidson County Drug Court (DC4) Women's Residential Hall was named in her honor in 2000; and

WHEREAS, Representative Sontany is recognized throughout the great State of Tennessee as a dedicated and well-informed legislator who always votes her conscience with the interest of the good people of House District 53 in her heart; and

WHEREAS, throughout her illustrious career as a public servant, Janis Sontany has worked tirelessly on behalf of her constituents, bringing to her office an honorable bearing and the traditional values of hard work and common sense; and

WHEREAS, her many civic and professional accomplishments aside, Janis Sontany is most appreciative of the love and companionship she shares with her two children; and
