WHEREAS, under the astute leadership of Coach Rachel Gray, the Lady Panthers (23-1) achieved an extraordinary level of success, capping a stellar season by securing a 55-34 victory over the Midway Middle School Lady Green Waves in the state section championship game; and

WHEREAS, the Lady Panthers knew they were in a fight from the opening whistle; at the end of the first quarter, the game was tied 12-12, but Lenoir City forged ahead to 25-21 at the half; and

WHEREAS, in the third quarter, Lenoir City remained undaunted, displaying strong defense and putting forth their best scoring quarter with players Maegan Hudson, Jaila Arnwine, and Amberlee Zeller all contributing points, increasing the margin to 41-29; and

WHEREAS, in the fourth quarter, Lady Panther Jermeria Dortch had the hot hand down the stretch, scoring six of her eleven points in the final frame, and Ashlynn Zeller banged in a field goal and a free throw for three points as the Lady Panthers coasted to the final buzzer with the sectional title in hand; and

WHEREAS, Ms. Hudson had the game-high scoring total of twenty-three points, Ms. Dortch had eleven, and Ms. Arnwine netted ten; and

WHEREAS, Ashlynn Zeller added six points overall and Amberlee Zeller contributed five points; and

WHEREAS, Jaila Arnwine, Amberlee Zeller, Ashlynn Zeller, Jermeria Dortch, and Maegan Hudson were named to the All-Tournament team, and Ms. Hudson was also named the tournament's Most Valuable Player; and

WHEREAS, the members of the Lenoir City Middle School girls' basketball team epitomize all that is good in today's student-athlete, as they have achieved a premier level of success in competition while exhibiting the highest degree of character in all aspects of life; and
