WHEREAS, Jackson Taylor's display of intellectual aptitude and ambition surely bodes well for his future success; and


WHEREAS, Mr. Taylor's dedication to excellence is clearly deserving of the respect, admiration, and commendation of this legislative body; now, therefore,
