WHEREAS, Ms. Loggins was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for her fellow citizens in numerous capacities; and

WHEREAS, born on January 24, 1931, in Memphis, Ms. Loggins was the devoted daughter of George and Willie Johnson, who taught her the value of hard work and service to others; and

WHEREAS, an assiduous scholar, Lillian Loggins graduated from LeMoyne-Owen College with honors in 1962 and later earned her Master of Education degree from Memphis State University; and

WHEREAS, a woman of faith, Lillian Loggins was a devout member of the Bethel Presbyterian Church for more than six decades, serving her Lord and fellow believers as a Deacon, Elder, Trustee, and the Presbyterian Woman; and

WHEREAS, Ms. Loggins was deeply devoted to her family, and she always endeavored to remain true to family values of the highest order; and

WHEREAS, she was preceded in death by her beloved son, Kevin Earl; and

WHEREAS, Lillian Loggins was the proud mother of Betty Marie Smith (Percy), Norman Cedric, and Wallace Eugene and the devoted grandmother of Norman Cedric Loggins I!, Edythe Marie Smith, Cory Xavier Loggins, Amina Abasi Smith, and Cierra Francine Loggins; and
