WHEREAS, strongly committed to community and public service, Scottie Goodman has endeavored to serve her fellow citizens by volunteering her time and talents to a number of worthy causes and organizations; she is a vice-president of the Hamilton County Parent Teacher Association, Children's Director at First Christian Church, and a member of the Board of the American Lung Association; and

WHEREAS, her many accomplishments aside, Mrs. Summerlin is most appreciative of the love and support she receives from her husband, Dan Summerlin, and their twin sons, Jack and Jake; and

WHEREAS, epitomizing the spirit and commitment that are characteristic of a true Tennessean, Scottie Goodman Summerlin takes her place among the many noble citizens who have earned this State the nickname of "The Volunteer State"; and
