AN ACT to amend Chapter 663 of the Private Acts of 1911, as amended by Chapter 66 of the Private Acts of 1915; Chapter 150 of the Private Acts of 1990; and any other acts amendatory thereto, relative to the charter of the city of Madisonville.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Chapter 663 of the Private Acts of 1911, as amended by Chapter 66 of the Private Acts of 1915, as amended by Chapter 150 of the Private Acts of 1990, and any other acts amendatory thereto, is amended by deleting Section 16 in its entirety and by substituting instead the following:

Section 16. The mayor's salary shall be five hundred dollars (\$500) per month and the salary of each alderman shall be four hundred dollars (\$400) per month, effective for terms of office commencing after the election occurring in November of 2014.

SECTION 2. This act shall have no effect unless it is approved by two-thirds (2/3) vote of the legislative body of the city of Madisonville within sixty (60) days of its signing by the governor of this state. Its approval or nonapproval shall be proclaimed by the presiding officer of the city of Madisonville and certified to the secretary of state.

SECTION 3. For the purpose of approving or rejecting the provisions of this act, it shall be effective upon becoming a law, the public welfare requiring it. For all other purposes, it shall become effective as provided in Section 2.
