## **PUBLIC CHAPTER NO. 236**

### SENATE BILL NO. 1218

### By Mr. Speaker Ramsey

#### Substituted for: House Bill No. 976

AN ACT to amend Tennessee Code Annotated, to revise committee names in accordance with the Rules of Order of the Tennessee House of Representatives and the Tennessee Senate.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 43-1-607, is amended by deleting the language "the chair of the house agriculture committee and the chair of the senate labor, commerce and agriculture committee" and substituting instead "the chair of the agriculture and natural resources committee of the house of representatives and the chair of the senate energy, agriculture and natural resources committee".

SECTION 2. Tennessee Code Annotated, Section 43-1-704(c), is amended by deleting the language "the chair of the agriculture committee of the house of representatives and the chair of the commerce, labor and agriculture committee of the senate" wherever it appears and substituting instead "the chair of the agriculture and natural resources committee of the house of representatives and the chair of the energy, agriculture and natural resources committee of the senate".

SECTION 3. Tennessee Code Annotated, Sections 4-3-1012(b)(5), 4-3-1018(d)(4), and 4-3-1105(20), are amended by deleting the language "the energy and environment committee of the senate and the conservation and environment committee of the house of representatives" and substituting instead "the energy, agriculture and natural resources committee of the senate and the agriculture and natural resources committee."

SECTION 4. Tennessee Code Annotated, Section 11-3-121(c), is amended by deleting the language "the parks and tourism subcommittee of the conservation and environment committee of the house of representatives, and approved by such standing committee of the house of representatives, as well as approved by the energy and environment committee of the senate" and

substituting instead "the agriculture and natural resources subcommittee of the house of representatives, and approved by such standing committee of the house of representatives, as well as approved by the energy, agriculture and natural resources committee of the senate".

SECTION 9. Tennessee Code Annotated, Section 11-7-104(h), is amended by deleting the language "chair of the energy and environment committee of the senate, chair of the conservation and environment committee of the house of representatives" and substituting instead "chair of the energy, agriculture and natural resources committee of the senate, chair of the agriculture and natural resources of representatives".

SECTION 10. Tennessee Code Annotated, Section 69-3-142(a), (b) and (d), is amended by deleting the language "the chair of the energy and environment committee of the senate and the chair of the conservation and environment committee of the house of representatives" and substituting instead "the chair of the energy, agriculture and natural resources committee of the house of representatives".

SECTION 11.
