WHEREAS, Mr. Lax was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, Franklin D. Lax, Sr., served with acumen and alacrity as Constable of Madison County, having first been elected to that position in 1972 and earning the respect of his peers and superiors alike for the exemplary quality of his work; and

WHEREAS, a genuine civic leader, Franklin D. Lax, Sr., served as a County Commissioner, a City Judge, and founder of the Tennessee Constables' Association; and

WHEREAS, Mr. Lax was also deeply devoted to his loving wife, Annie Ruth, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, Franklin D. Lax, Sr., leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and

WHEREAS, it is fitting that this General Assembly should pause to remember the bountiful life of this exceptional public servant and human being; now, therefore,
