A RESOLUTION recognizing Steve A. Garner upon his receipt of the twenty-seventh annual Palmer Veterans Appreciation Award.

WHEREAS, he was stationed on Okinawa with the 3rd Marine Division at Camp Sukiran from March of 1964 to September of 1965, when he returned stateside to his final duty station, Quonset Point, Rhode Island Naval Air Station, where he served until his discharge in May of 1967; and

WHEREAS, Steve Garner is a dedicated member of society who inspires those around him and commits himself to the improvement of his community, state, and nation; and

WHEREAS, Mr. Garner performed his duties with honor, distinction, and a profound regard for the importance of his role as a Marine, and his service can only be categorized as outstanding; now, therefore,
