WHEREAS, previously, she served with acumen and alacrity as a teacher at Halifax County High School in South Boston, Virginia; and

WHEREAS, Ms. Ramsey is an extremely talented and compassionate educator who has worked assiduously to motivate her students to reach their full potential, both as scholars and as citizens; and

WHEREAS, an organized professional who has always set high expectations for her students, Nancy Ramsey truly served as an inspiration to her colleagues and students alike during her career, and her friendship and counsel are highly valued by those who are fortunate to know her; and

WHEREAS, throughout her estimable career, Ms. Ramsey has demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of her community at large; and

WHEREAS, Nancy Ramsey truly epitomizes the dedicated teacher who is wholly committed to the highest ideals of public service and quality education for all, and she should be specially recognized for her manifold achievements on the occasion of her retirement; now, therefore,
