A RESOLUTION to honor the memory of Major L. DeBerry of Memphis.

WHEREAS, the members of this General Assembly were greatly saddened to learn of the death of Major L. DeBerry of Memphis; and

WHEREAS, born on November 8, 1922, in Senatobia, Mississippi, Major DeBerry was the seventh of eight children born to the late Reverend Franklin DeBerry and Nettie Peal DeBerry; and

WHEREAS, a devout Christian all his life, Mr. DeBerry first worshipped at Macedonia Baptist Church, where his father served as pastor; and

WHEREAS, he attended Macedonia Elementary and Junior High Schools before enlisting in the United States Army, with whom he valiantly served his country for four years in World War II; and

WHEREAS, upon his honorable discharge from the military, he moved to Memphis and joined the Mt. Nebo Missionary Baptist Church, where he served as member of the Usher Board until he joined the Union Valley Baptist Church, where he was a faithful and active member until his health began to fail; and

WHEREAS, a highly skilled machinist, Mr. DeBerry served with acumen and alacrity with the American Finishing Company for nearly twenty years; and

WHEREAS, he later worked for the General Cable Corporation, where he performed work of the highest quality until his well-earned retirement; and

WHEREAS, though he looked forward to his retirement, he remained active in his community and enjoyed a successful career as a licensed barber for many years; and

WHEREAS, a dedicated son and brother, he was preceded in death by his parents, Reverend Franklin DeBerry and Nettie Peal DeBerry; his brothers, Preston DeBerry, Timothy DeBerry, Roosevelt DeBerry, Samuel DeBerry, and Milton DeBerry; and his sisters, Bessie Mae Rushing and Dora Perkins; and
