HOUSE JOINT RESOLUTION NO. 160

A RESOLUTION to honor and commend the outstanding work of the Boys and Girls Clubs in Tennessee and its 2013 Youth of the Year candidates.

WHEREAS, the mission of the Boys and Girls Clubs (BGC) Tennessee Alliance is to enable young people, especially those who need us most, to reach their full potential as productive, caring, and responsible citizens; and

WHEREAS, the Boys and Girls Clubs Tennessee Alliance is comprised of twenty-one organizations with seventy-five facilities across the state, serving 59,600 members annually; and

WHEREAS, established in 1947, the Youth of the Year is the Boys and Girls Clubs' premier recognition program for club members, promoting service to club, community, and family; academic success; strong moral character; life goals; and poise and public speaking ability; and

WHEREAS, the program is most effective when used as a year-round tool for fostering the young people's character, personal growth, and leadership qualities. The club recognizes members ages fourteen to eighteen as Youth of the Month winners and a Youth of the Year, who then participate in state competitions; and

WHEREAS, state winners each receive a \$1,000 scholarship and participate in regional competitions. Five regional winners each receive a \$10,000 scholarship and compete on the national level. The National Youth of the Year receives up to an additional \$50,000 scholarship and is installed by the President of the United States; and

WHEREAS, the 2013 candidates for the Youth of the Year program in Tennessee are outstanding representatives of the Boys and Girls Club experience and its impact on children and youth in the state; and
