During her career with the legislature, her inimitable talents and unwavering professionalism benefitted a number of legislators, among them Representative Ed Haley, Representative David Shirley, Representative Richard Venable, former Representative and current Secretary of State Tré Hargett, Lieutenant Governor Ron Ramsey, Representative Doug Gunnels, Representative John Mark Windle, Representative Butch Borchert, and Representative Bill Harmon during his tenure as Chair of the House of Transportation Committee; and
