A RESOLUTION to recognize Paul Steven Chapman for his meritorious service as Chairman of the Hamblen County Republican Party.

WHEREAS, it is fitting that this General Assembly should salute those estimable persons who are deserving of recognition as community leaders and model citizens of whom we can all be proud; and

WHEREAS, one such person who has evinced great pride and accomplishment throughout the great State of Tennessee is Paul Steven Chapman; and

WHEREAS, Mr. Chapman has worked diligently as the Chairman of the Hamblen County Republican Party, a crucial leadership position he has admirably fulfilled since 2011; and

WHEREAS, from 1988 to 2003, he was an active member of the Tennessee Federation of Young Republicans, serving two terms as the Young Republicans Regional Vice President for East Tennessee; and

WHEREAS, in addition to his work in politics, Mr. Chapman has worked with Boy Scouts of America, the Ministerial Association Temporary Shelter, Ridin' High Equestrian Program, and was the President of the Cherokee Lake Users Association; he currently serves on the Morristown Area Chamber of Commerce's legislative committee and is on the board of Serenity House; and

WHEREAS, Mr. Chapman is a faithful member of First Baptist Church in Morristown, the place where he and his family worship; and

WHEREAS, he cherishes the love of his devoted wife, Jawanna; and is the proud parent of two sons, Paul Steven Chapman II and Aaron Joseph Chapman; and

WHEREAS, Mr. Chapman has devoted much of his life to political leadership and continuously strives for and lives by the values that our nation is built on; and

WHEREAS, the success of the State of Tennessee, the strength of our communities, and the overall vitality of our society depend, in great measure, on the dedication of people like
