
WHEREAS, Ms. Coffelt's dedication to excellence is clearly deserving of the respect, admiration, and commendation of this legislative body; now, therefore,


BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
