WHEREAS, she graduated from Covenant College with a degree in organizational management and she is a graduate student at the University of Tennessee at Chattanooga, where she is working on her Master's of Accountancy degree; and

WHEREAS, Bliss Welch serves with acumen and alacrity in the accounting department at Island Cove Marina; and

WHEREAS, active in her community, Ms. Welch has raised more than \$4,000 for the Muscular Dystrophy Association, she has been a guest speaker at the International Dysferlin Conferences, and she serves as an IRS Volunteer Income Tax Assistant; and

WHEREAS, in her free time, Bliss Welch enjoys spending time with her family and deer hunting; and

WHEREAS, her numerous accomplishments aside, she is also deeply devoted to her family and she always endeavors to remain true to family values of the highest order; and

WHEREAS, Ms. Welch is perhaps most proud of the love and companionship she shares with her husband, Jeremy, and their daughter, Annabelle; and


WHEREAS, Bliss Welch has attained excellence in many diverse fields of human endeavor and she should be specially recognized; now, therefore,
