WHEREAS, Hubert Clyde Hill was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, born in 1927, Hubert Clyde Hill was the son of Henry and Mary Hill; he was raised in Virginia and eventually moved to Kingsport, Tennessee to work at the Eastman plant; and

WHEREAS, Hubert Clyde Hill served his country with honor and valor during World War II; he was a tank driver in the Special Tank Battalion 738th, also known as the Great Speckled Bird unit; and

WHEREAS, as a member of the United States military, Hubert Clyde Hill earned numerous medals and ribbons including the Bronze Star Medal, Good Conduct Medal, Purple Heart Medal, and the European American Middle Eastern Service Ribbon; and

WHEREAS, Hubert Clyde Hill was an active and devout member of Morrison City Mission Church which he served faithfully for many years as a Bible teacher and Deacon; he was a student of the Word of God and lived its precepts in his daily life; and

WHEREAS, Hubert Clyde Hill was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, Hubert Clyde Hill was grandfather to the first brothers to serve in the State House simultaneously; and

WHEREAS, he enjoyed the loving companionship of his wife of sixty-six years, Erma Lee Hill; and

WHEREAS, he will also be sorely missed by his daughter and son-in-law, Brenda and Ed Miller; son and daughter-in-law, Kenneth and Janet Hill; grandsons, Nathan Miller and wife Ashley, Representative Matthew Hill and wife Amanda, and Representative Timothy Hill; granddaughters, Lee-Anna Miller Thomas and husband Rocky, and Lydia Hill; great-grandchildren, Presley Miller, Jon Thomas, Caleb Hill, and Abigail Hill; brothers, Carl Hill and wife Reta and Rev.
