WHEREAS, Mr. Wilkerson enjoyed the loving companionship of his wife, Jane, and was the proud father of two children; and

WHEREAS, Jackie Wilkerson leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and


BE IT FURTHER RESOLVED, that we express our sympathy and offer our condolences to the family of Mr. Wilkerson.
