WHEREAS, Judge Freeman C. Marr is one such laudable individual who demonstrates the greatest integrity and probity in all his chosen endeavors; and

WHEREAS, Judge Marr's impeccable career was recently honored when he received the American Citizenship for Freedom and Excellence Award; and

WHEREAS, highly respected within his community, Judge Marr has served Bartlett, Tennessee, for forty-five years, having served four terms as the City of Bartlett Judge and as the Bartlett Municipal Court Judge with General Sessions Jurisdiction since 1981; and

WHEREAS, Judge Marr has served as a Special Judge in Memphis on many occasions and worked as an attorney before his judicial career; and

WHEREAS, Judge Marr graduated from South Law University, now the University of Memphis, and Southwestern at Memphis, now Rhodes College, and is a member of Omicron Delta Kappa and Sigma Alpha Epsilon; and

WHEREAS, he has a passion for track and field, and Judge Marr was a two-time All American United States Track and Field Federation athlete and coached track at his alma mater, Rhodes College; and

WHEREAS, an involved member of his community, Judge Marr has served as the Rhodes College Alumni Association president, a two-term Alderman for the City of Bartlett, a volunteer firefighter, and a volunteer policeman; and

WHEREAS, a faithful Christian, Judge Marr has served on the Vestry for Grace St. Luke's Episcopal Church and St. Philip Episcopal Church and is a past chancellor and chairman of the school board for Grace St. Luke's; and

WHEREAS, Judge Marr is wholly committed to the noble precept of public service, exemplifies the spirit of a true Tennessean, and should be specially recognized; now, therefore,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED EIGHTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE SENATE CONCURRING, that we hereby honor the Honorable Freeman C.
