WHEREAS, Bill Jones is an involved member of his community, and is a board member for the Christy-Houston Foundation, the chairman of Destination Rutherford, the director of the Middle Tennessee Medical Center, and the director of the Middle Tennessee State University Jones College of Business; and

WHEREAS, Bill Jones has been a member of the Middle Tennessee Medical Center Foundation's Trustee and Executive Committee, a Rutherford County Industrial Development Board member, chairman of the Rutherford County Chamber of Commerce, president of the Middle Tennessee State University Foundation, co-chairman of the American Heart Association's Rutherford County Heart Gala, and a member of the Saint Thomas Health Systems Foundation Investment Committee; and

WHEREAS, Kathryn Jones is the president-elect of the Middle Tennessee State University Foundation, the president of RutherfordCABLE, the campaign vice-chair of the United Way of Rutherford County Board, and a member of the Murfreesboro Planning Commission; and

WHEREAS, Kathryn Jones was previously a member of the Webb School Board of Trustees, the Webb School Parents' Association, the president of the Murfreesboro Charity Circle, the Murfreesboro Historic Zoning Commission, and the Rutherford County Heart Ball chair and auction chair; and

WHEREAS, Mrs. Jones is a graduate of Rollins College and Middle Tennessee State University, and in her professional life she is president of Stewart Title Company, Tennessee Division and the owner of Artisan Design Gallery, an online jewelry and glass art website; and

WHEREAS, Mr. and Mrs. Jones are long-time members of St. Paul's Episcopal Church, where they are co-treasurers; and




