WHEREAS, Ms. Arthur had greater success during Season 12 of *American Idol*, during which she reached the top 5 and attracted numerous fans due to her southern charm, stunning vocals, trademark cowboy boots, and stage performance; and

WHEREAS, she was honored during the season finale of *American Idol* by The Band Perry, who invited her to join them on stage during their guest performance; and

WHEREAS, Janelle Arthur has performed on numerous stages since her days on *American Idol*, including at the CMT One Country & Sheba event as well as four performances at the Grand Ole Opry since her debut in June 2012; and




BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
