WHEREAS, one such noteworthy public servant is Rebecca Hilleary, a young woman who has been selected to receive the American Lung Association of Tennessee's 2014 Young Woman of Distinction Award; and

WHEREAS, Rebecca has somehow found time to be actively involved with her fellow students at Rhea County High School; she was a cheerleader for four years, led the Fellowship of Christian Athletes, represented the school at Girls State, and contributed many hours as a peer tutor for several severely handicapped students; and

WHEREAS, a skilled dancer, this Renaissance youth has taught dance to many younger students at the Dayton Christian Ballet; and

WHEREAS, in the community, Rebecca has made great contributions by working weekly with the Ronald McDonald House and the Women's Care Center and participating in Girl Scouts, 4-H, mission trips, and church youth group community service; and

WHEREAS, Rebecca served as the 2013 Distinguished Young Woman of Rhea County; in this important role, she visited every school in the county with a positive-message platform
