WHEREAS, Commissioner Bledsoe's remarkable success as a public servant and civic leader is directly attributable to his reliance on the time-honored values of hard work and common sense and his uncommon ability to work well with people from all walks of life; and

WHEREAS, Roy Bledsoe is an extremely giving person who often reaches out with compassion to people whom life has treated unkindly, and he epitomizes the ideal of the consummate professional, dedicated public servant, and reliable friend and neighbor; and

WHEREAS, in addition to his role on the Loudon County Commission, Commissioner Bledsoe joined the Sweetwater Hospital Home Health Advisory Board in 1984; and

WHEREAS, in his private life, he was also a dairy farmer for forty-two years, and for a time, he ran a creamery with his brother; he is also a member of the Gideons, the Masonic Lodge, and the Lions Club; and

WHEREAS, Commissioner Bledsoe is an active member of First Baptist Church of Philadelphia, which he has attended for over sixty years and has served as a deacon for more than forty years; and

WHEREAS, his many accomplishments aside, Roy Bledsoe is fortunate to share both love and companionship with his wife, Sarah, their daughter, Hope, and their three grandchildren, Cole, Will, and Abbi; and

WHEREAS, Commissioner Bledsoe is wholly committed to the noble precepts of public service that have earned Tennessee recognition as the "Volunteer State," and he should be specially recognized; now, therefore,
