## HOUSE JOINT RESOLUTION NO. 912

A RESOLUTION to recognize the outstanding work of the Boys and Girls Clubs in Tennessee and the Youth of the Year Candidates.

WHEREAS, the mission of the Boys and Girls Clubs (BGC) Tennessee Alliance is to enable all young people, especially those who need it most, to reach their full potential as productive, caring, and responsible citizens; and

WHEREAS, the Boys and Girls Clubs Tennessee Alliance is comprised of twenty-one organizations with seventy-five facilities across the state, serving 31,546 members annually; and

WHEREAS, established in 1947, the Youth of the Year is the Boys and Girls Clubs' premier recognition program for club members, promoting service to club, community, and family; with guidance in academic success, strong moral character, life goals, poise and public speaking ability; and

WHEREAS, the program is most effective when used as a year-round tool for fostering young people's character, personal growth, and leadership qualities; and

WHEREAS, the Tennessee Alliance of Boys and Girls Clubs holds an annual Youth of the Year state competition to recognize outstanding club members. Participants are club members ages fourteen to eighteen who are selected by their individual clubs as Youth of the Month winners and ultimately, the club Youth of the Year; and

WHEREAS, state winners will go on to compete at the regional level, and five regional winners will be selected to compete on the national level; the National Youth of the Year is installed by the President of the United States; and

WHEREAS, the 2014 candidates for the Youth of the Year program in Tennessee are outstanding representatives of the Boys and Girls Club experience and its impact on children and youth in the State; and
