HOUSE JOINT RESOLUTION NO. 1164

WHEREAS, Mrs. Phillips exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and

WHEREAS, Candy Phillips and her husband of forty-eight years, Bill R. Phillips, have three children and seven grandchildren; and

WHEREAS, throughout her estimable career, Candy Phillips has demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of colleagues; now, therefore,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED EIGHTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE SENATE CONCURRING, that we extend to Candy Phillips our heartfelt wishes for a happy and fulfilling retirement and every continued success in her future endeavors.
