WHEREAS, Matthew Christley demonstrated distinguished leadership in the youth offices of Troop 456, of the Trail of Tears District in the Middle Tennessee Council; and

WHEREAS, he worked to design, build to completion and provide leadership and direction for an arduous project that now benefits the good of citizens of Murfreesboro, Tennessee; enhancing their Bark Park, located at 1540 W. College Street, by providing a much-needed pavilion to shelter from heat and precipitation; and
