A RESOLUTION to recognize Jan McNally on the occasion of her retirement from Covenant Health.

WHEREAS, though she earned a well-deserved retirement in 2007, her colleagues convinced her to stay on as Corporate Director of Leadership Development; and

WHEREAS, in this current position, she has devoted herself to encouraging Covenant Health's 10,000 employees to develop innovative strategies for professional growth, excellent customer service, and quality patient care; and

WHEREAS, her peers and superiors alike will continue to benefit from her advice, support, and fearless innovation for years to come; and

WHEREAS, Ms. McNally exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and
