SENATE JOINT RESOLUTION NO. 195

A RESOLUTION to honor and recognize the Tennessee Delta Chapter of Phi Kappa Psi Fraternity on the occasion of their installation at Vanderbilt University.

WHEREAS, it is fitting that this General Assembly should pause to pay tribute to those exemplary organizations on our college campuses that have given unselfishly of themselves, their time, and their talents to perpetuate the public good; and

WHEREAS, fraternities and sororities have played a major role in American college life since 1776 and have been major contributors to the cultural, social, and civic lives of their communities; and

WHEREAS, an outstanding example of the Greek system at work is the Phi Kappa Psi Fraternity, which has been an organization possessed of a long tradition of excellence since its founding on February 19, 1852; and

WHEREAS, the Tennessee Delta Chapter of Phi Kappa Psi Fraternity was originally founded on the campus of Vanderbilt University on October 7, 1901, by nine bold charter members; and

WHEREAS, since that time, the Tennessee Delta Chapter of Phi Kappa Psi Fraternity has had a long-standing impact on Vanderbilt University and the Nashville community, having produced leaders both within and without the State of Tennessee; and

WHEREAS, in the 112-year existence of Tennessee Delta, the Chapter has initiated over 1,600 men of excellence into their strong band of brotherhood; and

WHEREAS, on February 23, 2013, after a previous period of inactivity on the Vanderbilt University campus, the Tennessee Delta Chapter was granted a charter and formal recognition from the Executive Council of Phi Kappa Psi; and

WHEREAS, this accomplishment would not have been possible without the help and support of local alumni members of the fraternity, most notably Brother Charles S. Higgins, Jr., Tennessee Delta, '67; and

WHEREAS, invaluable help and assistance was provided by Ms. Kristin Shorter, Director of Greek Life at Vanderbilt University, without which, it is highly unlikely these events would have transpired; and

WHEREAS, Brother Ronald Ransom, Indiana Zeta, '00, who served as the Director of Expansion for the Phi Kappa Psi Fraternity, worked tirelessly with the undergraduate members, helping them achieve this important milestone; and
