SENATE RESOLUTION NO. 36

A RESOLUTION recognizing the students and teachers of the Jeanette C. Rudy School of Nursing at Cumberland University attending the 2013 TNA Legislative Summit.

WHEREAS, the Jeanette C. Rudy School of Nursing students who will be attending the Legislative Summit will do so in the company of Ronda Landers, RN, MSN, and Beth Chatham, RN, MSN, CPN, two of the students' educators, and nursing mentors of the highest caliber; and

WHEREAS, it is wholly fitting that this body recognize the students and teachers of the Jeanette C. Rudy School of Nursing for their commitment to the pursuit of excellence in nursing and health care; now, therefore,
