WHEREAS, Mr. Stone Carr of Blount County is one such estimable person who evinces the greatest integrity and probity in all his chosen endeavors; and

WHEREAS, the owner of his own construction company, Mr. Carr has personally redefined the term "public servant" to include a higher level of benevolence as a generous giver, community leader, impeccable role model, and dedicated mentor; and

WHEREAS, during the course of his illustrious career, Mr. Stone served with distinction on the Blount County Museum board of directors, Blount County long range planning committee, H.O.M.E. WHEREAS, he has been a strong supporter of the Boys and Girls Club and has worked diligently to restore and maintain Maple Grove Cemetery in Maryville; and

WHEREAS, a gentleman of devout Christian faith, Stone Carr served God and humanity as the pastor of Shiloh Presbyterian Church, Emmanuel Presbyterian Church, and Rest Haven Presbyterian Church and is a member of the Blount County Ecumenical Council; and

WHEREAS, Mr. Carr has twice received the Pride of Tennessee Award, in 1995 and 2007, from the Blount County mayor for best exemplifying a "Tennessee Volunteer" through his community involvement and his ongoing efforts to make Blount County an even better place to live and work; and

WHEREAS, he is most grateful for the love and companionship he shares with his wife, Gloria D. Carr; his three children, Pamela Carr Tate, Stanley N. Carr, and Gina T. Carr; and his three siblings; and

WHEREAS, Stone Carr is wholly committed to the noble precepts of public service that have earned Tennessee recognition as the "Volunteer State," and he should be specially recognized; now, therefore,
