WHEREAS, Marshal "Papa" Swafford Sr. will celebrate his 100th birthday on March 17, 2015, a milestone that will be commemorated as yet another precious souvenir of life's rich pageant; and

WHEREAS, a highly respected member of the Pikeville community, Mr. Swafford Sr. has lived a blessed life, having experienced firsthand the most eventful and productive years in American history; and

WHEREAS, born in the New Harmony community to Jim and Edwina Swafford, Marshal Swafford Sr. worked on the family farm with his parents, his four brothers, and his two sisters; and

WHEREAS, when he was eight years old, the family moved to Stevenson, Alabama, where he spent much time by the Tennessee River, playing and fishing. The Swaffords moved to Pikeville seven years later; and

WHEREAS, in 1936, Marshal Swafford Sr. met and married Margaret Marie Rothwell, and the couple's blessed union produced five sons, Herbert, Hershal, Marshal Jr., Wayne, and Willard; and

WHEREAS, Papa Swafford bought a farm and worked on the farm until he reached the age of ninety-five, growing strawberries and vegetables. Later, tomatoes became his main crop, and he was known for his cattle; and

WHEREAS, from 1943 to 1945, he worked at Oak Ridge, where the atomic bomb that was dropped on Japan was developed; and

WHEREAS, a man of integrity and a devout Christian, Marshal Swafford is known for his wit and laughter and has countless true friends. His motto is "Do unto others as you would have them do unto you."; and

WHEREAS, as Mr. Swafford Sr. approaches his eleventh decade, he is still an active and productive member of society, participating in various civic and community events; and

WHEREAS, we wish to grasp this golden opportunity to specially recognize one of Tennessee's most outstanding citizens on this very special occasion; now, therefore,


