WHEREAS, the Masons' Hess Lodge has been in continuous operation since 1840, to the great benefit of all Dyer Countians; and

WHEREAS, current officers include Rob Hammond, the Worshipful Master; David Chrisman, the Senior Warden; Scott Hall, the Junior Warden; Mike Lamb, the Treasurer; Stephen Dycus, the Secretary; Paul Tally, the Senior Deacon; Wayne Waldron, the Junior Deacon; Jay Wells, the Senior Steward; Danny O Parker, the Junior Steward; Gayle Percival, the Tyler; and James Strayhorn, the Chaplain; and

WHEREAS, many Dyersburg Masons have distinguished themselves as men of stature in our great state and nation; and

WHEREAS, the Dyersburg Masons have further assisted the youth of our state through the inspirational leadership they provide in their community; and

WHEREAS, it is for the noble efforts of the Hess Masonic Lodge #93 of Dyersburg that this legislative body is most thankful; now, therefore,
