HOUSE JOINT RESOLUTION NO. 68

A RESOLUTION to confirm the appointment of William L. Campbell Sr. of Nashville to the State Textbook and Instructional Materials Quality Commission.

WHEREAS, Tennessee Code Annotated, Section 49-6-2201, provides for the creation of the State Textbook and Instructional Materials Quality Commission; and

WHEREAS, Tennessee Code Annotated, Section 49-6-2201(a)(1)(B), provides that the Speaker of the House of Representatives shall appoint one (1) member from each grand division of the state to the State Textbook and Instructional Materials Quality Commission; and

WHEREAS, Tennessee Code Annotated, Section 49-6-2201(b)(2), provides that the one (1) member from each grand division of the state shall be a citizen of this state who is not employed in the public kindergarten through grade twelve (K-12) educational system, but who is knowledgeable of education issues in this state; and

WHEREAS, Speaker of the House of Representatives Beth Harwell, acting pursuant to Tennessee Code Annotated, Section 49-6-2201(a)(1)(B), has appointed William L. Campbell Sr. as a member representing Middle Tennessee on the State Textbook and Instructional Materials Quality Commission for a term that commences January 1, 2015, and expires December 31, 2017; and

WHEREAS, William L. Campbell Sr. serves on the board of trustees for Oak Hill School in Nashville, which is an outreach of First Presbyterian Church. Prior to this position, he served as interim head of school for Oak Hill School, head of school for The Covenant School in Nashville, headmaster at Tuscaloosa Academy in Alabama, headmaster at Memphis University School, and headmaster at Franklin Road Academy; and


WHEREAS, Mr. Campbell was a member of the Educational Records Bureau from 1986 to 2004, during which time he served on that bureau's board of trustees from 1994 to 2004, and as president from 1999 to 2003; in addition, he was a member of the Alabama Association of Independent Schools, the Southern Association of Independent Schools, and the National Association of Independent Schools; and

WHEREAS, Tennessee Code Annotated, Section 49-6-2201(d)(1), provides that each member, prior to beginning a term of office, shall be confirmed by joint resolution of the General Assembly; now, therefore,


