He is a former National Agriculture Teacher of the Year recipient and, as a principal, was named the 2000 Distinguished Administrator of the Year by the Tennessee Education Association; and

WHEREAS, active in his community, he is a member of the Sons of the American Revolution and a longtime congregant of Westmore Church of God, which he serves faithfully as an usher and as a member of the Grounds Committee; and

WHEREAS, Mr. Lackey's remarkable success as a public servant and civic leader is directly attributable to his reliance on the time-honored values of hard work and common sense and his uncommon ability to work well with people from all walks of life; and

WHEREAS, Herbert Lackey is an extremely giving person who often reaches out with compassion to people whom life has treated unkindly, and he epitomizes the ideal of the consummate professional, dedicated public servant, and reliable friend and neighbor; and

WHEREAS, Herbert Lackey is wholly committed to the noble precepts of public service that have earned Tennessee recognition as the Volunteer State, and he should be specially recognized; now, therefore,
