A RESOLUTION to congratulate Commissioner Jim Henry of the Department of Children's Services upon his receipt of the Childhelp Voice of the Children Award.

WHEREAS, the department's inspirational accomplishments cited by Childhelp include achieving its continued number-one national performance ranking in getting children placed in permanent and loving homes, revamping training, re-engaging partner agencies and improving working relationships, achieving greater transparency, delivering robust foster parent recruitment, retooling the Child Abuse Hotline, and becoming the first state in the nation to offer transitional living services to 100 percent of youth who age out of foster care; and

WHEREAS, the members of this legislative body find it appropriate to acknowledge and applaud Commissioner Jim Henry of the Department of Children's Services for his dedication to the state of Tennessee and its citizens on this special occasion; now, therefore,
