SENATE JOINT RESOLUTION NO. 38

A RESOLUTION to confirm the appointment of W. Chadwick Baker of Piney Flats to the Tennessee Fish and Wildlife Commission.

WHEREAS, Tennessee Code Annotated, Section 70-1-201, provides for the creation of the Tennessee Fish and Wildlife Commission; and

WHEREAS, Tennessee Code Annotated, Section 70-1-201, further provides that the Governor shall appoint nine members to the commission; and

WHEREAS, Governor Bill Haslam has appointed W. Chadwick Baker of Piney Flats to a term that will expire on February 28, 2019, as a member representing the 1st District; and

WHEREAS, an esteemed businessman, Mr. Baker is president of Baker's Construction Services, a heavy highway and site work contractor; and

WHEREAS, an active member of his community, W. Chadwick Baker is a past president of Speedway Children's Charities and a member of the Bristol Chamber of Commerce and the Tennessee Road Builders Association; and

WHEREAS, an avid outdoorsman who grew up on a farm where he learned to hunt and fish at a young age, Mr. Baker now enjoys teaching his children how to hunt and fish; and

WHEREAS, W. Chadwick Baker is a person of integrity and an active citizen whose benevolence, acumen, and strong commitment to public service have helped to enhance the well-being of this State and its citizens; and

WHEREAS, Tennessee Code Annotated, Section 70-1-201(b)(1), provides that each member appointed to the Tennessee Fish and Wildlife Commission by the Governor shall be confirmed by the House Agriculture and Natural Resources Committee; the Senate Energy, Agriculture and Natural Resources Committee; and Joint Resolution of the General Assembly; now, therefore,

BE IT RESOLVED BY THE SENATE OF THE ONE HUNDRED NINTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE HOUSE OF REPRESENTATIVES CONCURRING, that we hereby confirm the appointment of W.
