SENATE JOINT RESOLUTION NO. 48

A RESOLUTION to call a joint convention of the House of Representatives and the Senate for the purpose of inaugurating the Honorable Bill Haslam as Governor of the State of Tennessee, to provide for the adjournment of the One Hundred Ninth General Assembly organizational session, and to provide for the convention and recess of the 2015 regular session of the One Hundred Ninth General Assembly.

WHEREAS, Tennessee Code Annotated, Section 8-1-101, provides that the Governor shall take the oath of office on the first Saturday following the fourteenth day of January next following his election, after the commencement of the organizational session of the General Assembly in accordance with Article II, Section 8, of the Constitution of Tennessee; now, therefore,

BE IT RESOLVED BY THE SENATE OF THE ONE HUNDRED NINTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE HOUSE OF REPRESENTATIVES CONCURRING, that the House of Representatives and the Senate meet in joint convention on the Legislative Plaza on Saturday, January 17, 2015, at 11:00 a.m. (CST) for the purpose of inaugurating the Honorable Bill Haslam as Governor of the State of Tennessee.

BE IT FURTHER RESOLVED, that a joint committee, to be composed of three (3) members of the House of Representatives and three (3) members of the Senate, be appointed by the respective Speakers to escort the Honorable Bill Haslam to the podium to be inaugurated as Governor of Tennessee.

BE IT FURTHER RESOLVED, that the One Hundred Ninth General Assembly organizational session stand in adjournment at the close of business of the organizational session on Saturday, January 17, 2015.

BE IT FURTHER RESOLVED, that pursuant to Article II, Section 8, of the Constitution of Tennessee, the One Hundred Ninth General Assembly convene in regular session on Saturday, January 17, 2015, immediately following adjournment of the One Hundred Ninth General Assembly organizational session.

BE IT FURTHER RESOLVED, that the One Hundred Ninth General Assembly stand in recess at the close of business in both houses on Saturday, January 17, 2015, and reconvene in regular session on Monday, February 9, 2015, at 5:00 p.m. (CST).


