WHEREAS, excelling in her life's vocation, Ms. Scott's greatest attribute is her ability to get to know her residents personally, sharing their triumphs and comforting their sorrows. She often continues relationships with residents who are able to return home and can be found helping them bathe, preparing meals, providing transportation, or just spending time with them; and

WHEREAS, this General Assembly finds it appropriate to recognize and applaud Beth Ann Scott for her dedication to her profession and to the care of vulnerable citizens in the State of Tennessee; now, therefore,
