WHEREAS, he is survived by his brother, Jackson (Lois) Davis; his sisters, Billie Woods and Gayle (Doug) Gray; special friend, Dawn Davis; and numerous cousins, nieces, nephews, and other friends and loved ones; and

WHEREAS, in his free time, Mr. Davis trained and showed horses and supported local sports teams, including the Coalfield Yellow Jackets and the Wartburg Lady Bulldogs; and


BE IT FURTHER RESOLVED, that we express our sympathy and offer our condolences to the family of Mr. Davis.
