A RESOLUTION to honor the Franklin Special School District Board of Education on receiving the Tennessee School Boards Association 2015 School Board of the Year Award.

WHEREAS, from time to time, the members of the General Assembly pay recognition to those exemplary institutions and organizations that serve to improve their communities and bring honor to this State; and

WHEREAS, the Franklin Special School District (FSSD) Board of Education is one such organization that, in fitting recognition of its many contributions toward the pursuit of educational excellence in Franklin, was named the 2015 School Board of the Year by the Tennessee School Boards Association (TSBA); and

WHEREAS, a current Board of Distinction with TSBA, the FSSD Board works diligently to meet the challenges of a dynamic world while ensuring that every child receives the services needed for a quality education; and

WHEREAS, the Franklin Special School District Board of Education is composed of six board members, each having achieved a level of boardsmanship with TSBA, with Level V being Master Board Member status; and

WHEREAS, the members of the award-winning FSSD Board of Education are Tim Stillings, Chairman, Level V; Robert Blair, Vice Chair, Level V; Alicia Barker, Secretary, Level III; Robin Newman, Treasurer, Level II; Allena Bell, board member, Level III; and Kevin Townsel, board member, Level I; and

WHEREAS, FSSD Board members regularly visit district and school events to share their support; support professional learning within FSSD by funding innovative opportunities for faculty and staff, as well as ensuring their own growth by attendance at state and national conferences; actively participate and lend support in community events; participate in legislative events and learning opportunities; attend city and county commission meetings and monitor school district

activities across the region; and serve individually on a variety of district and community councils and committees; and

WHEREAS, it is wholly fitting that the members of this General Assembly formally recognize the Franklin Special School District Board of Education upon its receipt of this acclaimed award; now, therefore,
