HOUSE BILL NO. 2701

AN ACT to amend Chapter 395 of the Private Acts of 1937; as amended by Chapter 409 of the Private Acts of 1949; Chapter 69 of the Private Acts of 1961; Chapter 334 of the Private Acts of 1974; Chapter 134 of the Private Acts of 1990; Chapter 153 of the Private Acts of 1996; and any other acts amendatory thereto, relative to the County Highway Advisory Commission of Lewis County.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Chapter 395 of the Private Acts of 1937, as amended by Chapter 409 of the Private Acts of 1949, Chapter 69 of the Private Acts of 1961, Chapter 334 of the Private Acts of 1974, Chapter 134 of the Private Acts of 1990, Chapter 153 of the Private Acts of 1996, and any other acts amendatory thereto, is amended by deleting from the second paragraph of Section 2 the language that reads as follows:

The members of the commission shall receive forty dollars (\$40.00) per day for this service rendered and the chairman of the commission shall receive three hundred dollars (\$300) per month.

and by substituting instead the following:

The members of the commission shall receive fifty dollars (\$50.00) per month for this service rendered and the chairman of the commission shall receive two hundred dollars (\$200) per month.

SECTION 2. This act shall have no effect unless it is approved by a two-thirds (2/3) vote of the county legislative body of Lewis County. Its approval or nonapproval shall be proclaimed by the presiding officer of the county legislative body and certified to the secretary of state.

SECTION 3. For the purpose of approving or rejecting the provisions of this act, it shall be effective upon becoming a law, the public welfare requiring it. For all other purposes, it shall become effective as provided in Section 2.
