A RESOLUTION to honor the memory of Wayne H. Justice of Hendersonville.

WHEREAS, the members of this General Assembly were greatly saddened to learn of the passing of Wayne H. Justice; and

WHEREAS, Wayne Justice was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, the son of J.D. and Roberta Justice, Wayne Justice was born on October 27, 1938, and attended Isaac Litton High School; and

WHEREAS, Mr. Justice owned and operated two Exxon Service Stations, one located on Woodland Street and the other on Charlotte Pike. After many years of stalwart management, he sold the businesses and joined Ambulance and Coach Sales of Nashville in 1986. After becoming part-owner of the company, Mr. Justice helped supply the southeastern funeral industry with hearses and limousines for twenty-five years; and

WHEREAS, Mr. Justice was a member of the Tennessee and Mississippi Funeral Supply Sales Clubs, the Scottish Rite, the Al Menah Shrine Temple, and a fifty-year member of the Centre Star Lodge #409; he was a Jester and member of the Al Menah Shrine Horse Patrol; and

WHEREAS, an avid boater, Wayne Justice loved being on the waters of Old Hickory Lake; and

WHEREAS, he was a longtime member of College Heights Baptist Church and later joined Impact Fellowship in Gallatin; and

WHEREAS, Mr. Justice was deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, Wayne Justice is survived by his loving wife, Martha Justice; children, Andra Justice, Mike Justice, and Stephanie Vaughn; grandchildren, Hailey and Macey Justice, Megan Shearin, Bryson Anderson, and Tim and Andrew Vaughn; brother, Larry Justice; and a number of nieces and nephews; and

WHEREAS, Wayne Justice leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and

WHEREAS, it is fitting that the members of this General Assembly should pause to remember the bountiful life of this exceptional public servant and human being; now, therefore,
