She also coordinated social activities for the church's senior citizen group, The Young at Heart, and worked with other members of the church to provide a Sunday morning devotion at the Towers in Jellico; and

WHEREAS, Patsy Teague was also deeply devoted to her family and always endeavored to remain true to family values of the highest order, and she enjoyed the loving companionship of her husband, Craig Teague; and

WHEREAS, she will be fondly remembered by her brothers, Ray Maiden and Robert Maiden; her nieces, Carolyn Gilliam, Terri Maiden, Kim Bryant, and Deana Barton; her nephew, Andy Bill Maiden; and several great- and great-great-nieces and nephews; and
