WHEREAS, a graduate of McCreary County High School, Dennis Stephens studied diesel mechanics at the Somerset Vocational School; he plans to build hot rod cars during his retirement; and

WHEREAS, Dennis Stephens exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and


WHEREAS, throughout his estimable career, Mr. Stephens has demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of his colleagues; now, therefore,
